Johnson County School district supports parent communication and engagement with the performance of its schools. All schools in Johnson County Schools are school-wide Title I schools.

Under Georgia's ESEA Flexibility Waiver, certain Title I schools are designated as needing more support from the Georgia Department of Education (GDOE). The use of the College and Career Ready Performance Index (CCRPI), which serves as a comprehensive report card for all schools in Georgia provides a score between 0-100 for each school, and that score measures how well the school is doing in preparing its students to be successful in college and/or a career.

Johnson County School District CCRPI score is **64.2%**. Johnson County Elementary School score is **57.2%**. Johnson County Middle school **72.9%**, and Johnson County High School is **67.3%**. More information about CCRPI scores can be found at http://ccrpi.gadoe.org

We are very proud to tell you that <u>neither</u> of Johnson County Schools has been given a school designation this year, which means we are continuing to provide a quality education to all of our students. No school has been indicating the need for GDOE support. The school system continues to study data and make changes based on the data. Academically, the students of Johnson County are showing growth overall in Mathematics. Reading is showing areas of growth, but based on data still needs consistency targeted support.

In Johnson County Schools, we take pride in the teaching we provide for our children. Our administrators, teachers and staff members work very hard to meet the needs of all students to ensure they achieve at their highest potential. Since our district only has one school at each level, there is no choice of schools. However, each school has interventions, supplemental instruction, allocated times to provide enrichment and remediation for all students reach the academic goals.
