5. JCES Principal Charles Howard reported that staff members Becky Frost and Angela Tanner were presenters at a recent ESOL conference and congratulated them for doing a great job. - 7. Mr. Charlie Lindsey presented a facility use request from FCA to use the middle high school gym on March 11 13, 2016 for Breakthrough (formerly Crusade for Christ). Request was unanimously approved on a motion by Mr. Thompson, second by Mr. Brantley. Facility use fee will be waived.
- 8. Mr. Charlie Lindsey presented a facility use request from Relay for Life to use the football field on May 14, 2016. Request was unanimously approved on a motion by Mr. Brantley, second by Mr. Smith. Facility use fee will be waived.
- 9. Mr. Charlie Lindsey presented a facility use request from Job Training Unlimited to use the agri-center on March 22, 2016 for a job fair. Request was tabled until more information could be obtained.
- 10. Superintendent Thomas reminded board members of the whole board governance training on February 18. Superintendent Thomas reported that the forestry commission is waiting on an opportune time to do a controlled burn at the new property.
- 11. On a motion by Mr. Thompson, second by Mr. Brantley; unanimous approval was given to go into executive session to discuss or deliberate upon the appointment, employment, compensation, hiring, disciplinary action or dismissal, or periodic evaluation or rating of a public officer or employee and to discuss or vote to authorize negotiations to purchase, dispose of, or leave property; authorize ordering an appraisal related to the acquisition or disposal of real estate; enter into a contract to purchase, dispose of, or lease property subject to approval in a subsequent vote; or enter into an option to purchase, dispose of or lease real estate subject to approval in a subsequent public vote. After discussion, a motion was made to come out of executive session by Mr. Thompson, second by Mr. Brantley; unanimous approval.
