## Board Minutes January 15, 2019

The Johnson County Board of Education met in regular session on Tuesday, January 15, 2019 in the board office at 5:00 p.m. Kevin Brantley, Donald Smith, Chris Fields, Alvin P. Moorman, and Marty Thompson were present. Mr. Brantley called the meeting to order and welcomed everyone. Mr. Thompson gave the invocation and Mr. Smith led the Pledge of Allegiance to the flag.

## The following business was transacted:

- 1. The proposed agenda was approved on a motion by Mr. Smith, second by Mr. Fields; unanimous approval.
- 2. The December 11, 2018 regular meeting minutes were approved on a motion by Mr. Thompson, second by Mr. Fields; unanimous approval.
- 3. The December 2018 financial report was approved on a motion by Mr. Moorman, second by Mr. Thompson; unanimous approval.
- 4. Chairman Brantley called for nominations for Board Chair for 2019. Mr. Smith made motion to have Mr. Brantley remain as board chairman and Mr. Thompson remain as board vice chairman. Mr. Fields seconded the motion and it was unanimously approved.
- 5. Superintendent Morris discussed plans for the annual whole board training. The board agreed by consensus to have Superintendent Morris contact Attorney Phil Hartley and GSBA to plan the date for February or March.
- 6. Superintendent Morris presented a board meeting schedule for 2019. After much discussion, Mr. Moorman suggested that the schedule be consistent each month to allow for easier planning for school functions. He also noted that it would also be more conducive for the community. After much discussion, the meeting schedule was set on a motion by Mr. Fields, second by Mr. Smith; with Smith, Fields, Thompson, and Brantley voting yes and Moorman voting no. - 7. Superintendent Morris presented Policy DCL Fund Balance for second reading. This policy was approved on a motion by Mr. Fields, second by Mr. Smith; unanimous approval. Policy is attached and becomes a part of these minutes.

- 10. Dr. Christopher Watkins, Middle/High Principal, proudly announced that this year's STAR student is Avery Thompson and the STAR teacher is Mrs. Shirley Tharpe. The Middle school has 133 referrals and the High school has 148 referrals this year. This time last year was 195 and 334 respectively.
- 11. Mr. Charlie Lindsey, Director of Facilities, Transportation, and SIS, apprised the board that ESPN had called and would be in Wrightsville and Johnson County in the next few days.
